



## LIMITED WARRANTY

Afro-Industries (Pty) Ltd. (Afro-Industries) warrants, to the original purchaser, that this **BLU STOVE** ("the Stove" or "the Product") will be free of defects in material and workmanship for a period of 12 MONTHS from the date of purchase on the terms and conditions set forth herein.

Afro-Industries will repair or replace, at its sole option, any part of or the complete **BLU STOVE** found to be defective. The customer must, at his/her own expense, arrange to deliver or ship the stove or part to Afro-Industries and arrange for pickup or delivery of the stove or part after the repairs have been made. If upon inspection, the damage is found to be the fault of the manufacturer the repair or replacement will be made. Any **BLU STOVE** or part thereof that is repaired or replaced during the limited warranty period will be warranted for a period to not exceed the remaining term of the original limited warranty. This warranty is not transferable and is extended only to, and is solely for the benefit of, the original purchaser of the **BLU STOVE**. Please retain your dated sales receipt in your records as proof of purchase.

This warranty does not cover the following:

- Damage due to external causes, not attributable to manufacture or material defect.
- Repair or replacements of parts which are subject to normal wear and tear during the warranty period or to parts that may require replacement in connection with normal maintenance.
- Damage due to misuse which is not in conformity with the instructions/manual provided with the purchase of the **BLU STOVE**.
- Damage due to abuse, neglect or the unauthorised modification or repair.
- Damage due to failure to follow product instructions or warnings.
- Damage due to the use of any other fuel besides **BLU FUEL**.
- Damage due to the improper maintenance that is not accordance with the instructions or manual provided with the purchase of the **BLU STOVE**.

In no event shall Afro-Industries be liable for special incidental or consequential damages. All implied warranties, including the implied warranties of merchantability and fitness for a particular purpose, or otherwise, are limited in duration to the length of this written warranty. No oral or other written warranty is enforceable.

Excluding the limited warranty provided above, Afro-Industries, its affiliates and their suppliers, to the maximum extent permitted by law, make no warranties, expressed or implied, and disclaim all warranties, duties and conditions, whether expressed, implied or statutory, with respect to the product, including without limitation any implied warranties of merchantability, against latent defects, fitness for a particular purpose, or correspondence to description.
